## **TERMS AND CONDITION**

- 1. Membership fee shall be paid only by online banking procedure.
- 2. In case of lose of identity card or authorisation letter, immediately inform to regd. office and then police.
- 3. Improper information filled in membership form is the sole responsibility of the applicant only, and required disciplinary action is the taken which will result in cancellation of membership also.
- 4. If found involved in any type of offences or acting against rule and regulation of Committee will result in cancellation of membership or removal from the designated post.
- 5. Membership fee of similar or other parallel Committee is totally prohibited.
- 6. Membership fee, once deposited shall not be returned or accommodated or adjusted in any case.
- 7. Returning the identity card is mandatory on the withdrawal of membership from the Committee.
- 8. These post are of selfless service and of great respect, so never expert any kind of salary or other accommodation.
- 9. It is needed to follow all the regulation set by Committee.
- 10. Misusing the post or identity will be result in legal action.
- 11. Do not pay more than pre-determined membership fee.
- 12. If any of the officer demands for more money, its complaint should be logged with higher officers or the National Office.
- 13. Always be ready for Social Services.
- 14. Will have to work with the local administration & local Govt.
- 15. Always support the Committee.
- 16. The nomination will take 30-60 days of time period.
- 17. The nomination process will begin once all the reports will be verified.
- 18. If any case of the reports is found misleading than National Committee will take its own decision.
- 19. National Committee keeps its own decisions and right private and secure which is final and irreversible in any case.
- 20. Promotion of any officers will be done on the report given by their related office.
- 21. It is the duty of President to submit all the monthly reports by the first week of the month, in any case to the higher officers.
- 22. The President need to organize a monthly meeting with their members and volunteers, for which all the members or volunteers will be notified 7 days ahead of meeting in written or any social communication like email, mobile, message etc.
- 23. Reason for the absence will be submitted to the office in written.
